STATE OF THE EMPLOYEE ORGANIZATION REPORT

President Bobbi Vannattan talked about MACDEO related events for the past year. Our biennial administrator training took place in Helena, June 14, 15 and 16.

Each conservation district in the state was invited to bring a centerpiece with items that represented their county. This is an optional activity for those who would like to participate. These will be used at the banquet on Thursday evening.

In the past, the EO has assembled a mentoring list. This list is in need of updating. Anyone offering to be a part of this list is welcome. Some areas covered are: 310 process, Quickbooks accounting, grant writing and meeting minutes.

MEETING MINUTES

Calendar year

Our current fiscal calendar year runs from October 1 – September 30 which is concurrent with State of Montana calendar. Montana Conservation Districts run the from July 1-June 30. After discussion, it was suggested that we run the MACDEO fiscal calendar with the calendar year, January 1 – December 30. This would coincide more closely with our annual state convention. Mary Hendrix moved that we change the MACDEO fiscal calendar to coincide with the calendar year January 1 to December 30. Nea Rice seconded the motion. Motion carried.

Dues

Jennifer Anderson motioned that dues should be paid on the same calendar year as the MACDEO fiscal year, January 1- December 30. Tabitha Furnare seconded the motion. Motion carried.

Terms

A discussion ensued concerning terms of office for MACDEO officers and area representatives. Current bylaws state that the terms should be staggered, but staggering is not specific. We will look at developing a Terms Chart.

Other bylaw questions arose. It was decided that we would set up an MACDEO Bylaws Committee. Tenlee Atchison will head this committee.

Badges

According to our bylaws, the MACDEO has purchases badges for Administrators after their first year. Mary Hendrix moved that if the district would like to purchase a badge before the anniversary date, the cost would be for the badge plus postage to the district. Teresa Wilhelms seconded the motion. Motion carried.
