



MISSOULA COUNTY LOCAL WORK GROUP 2021 FOLLOW UP REPORT

On December 7th, 2021 the Local Working Group (LWG) met to discuss natural resource conservation concerns in Missoula County. There were 26 individuals (see Appendix A for details) that were able to attend and other partners/citizens that were unavailable. The LWG identified Priority Resource Concerns (PRC – see Appendix B for details) which will help the Natural Resource Conservation District (NRCS) decide what natural resource areas to focus on in upcoming Targeted Implementation Plans (TIPs). Those concerns will also be a starting place for the Missoula Conservation District as the District develops our new strategic management plan.

Here are the PRCs identified.

1. Wildlife Habitat/Fragmentation
2. Increased Development/Land Use Pressure
3. Water Quality/Quantity
4. Invasive Species
5. Forest Health
6. Soil Health

These Priority Resource Concerns are great for getting more conservation projects implemented on the ground. We desire to have the LWG to be more than just a tool for the Missoula Conservation District and NRCS. This year was a starting point, and we want the work of the group to be valuable to all attendees.

Next year's meeting will start where this year's meeting left off. That means beginning with the six Priority Resource Concerns established this year and quickly making sure they are still applicable. Once we satisfy that responsibility, the group will use our time to move shared projects forward.

We will identify who is doing projects in what areas and which partners they are working with. From here we will see what other resources and partnerships are needed and focus on building connections to serve those needs. We have a goal for those attending to have time to meet with one another and discover potential partnerships or deepen existing ones.

For example, let us use the NRCS's Miller Creek TIP to enhance riparian areas and aquatic habitats. This example is an NRCS-driven project, but the LWG doesn't need to be focused only on District or NRCS driven projects. We will spend time on other groups too. Some questions to ask are: Who are the current partners? Who else might be a potential partner? What are the remaining needs? What other opportunities are out there? It is important to consider that opportunities might be identified from partners not yet involved.

Miller Creek TIP Example:

Current Partners

NRCS (technical & monetary cost-share assistance)

Oxbow Cattle Company (access to land, technical assistance, monetary contributions, voluntary labor)

Local Property Owners (access to land, monetary contributions, potential voluntary labor)

FWP (technical assistance, labor/baseline assessments)

Clark Fork Coalition (technical & potential monetary cost-share assistance, outreach support)

Missoula Conservation District (technical & potential monetary cost-share assistance, outreach support)

Missoula Weed District (technical assistance, outreach support)

Remaining Needs

More volunteer labor


More public outreach

This is just one project that we are familiar with, but rest assured there are many other partnership potentials in the LWG that we can flush out.

We will have LWG participants list some projects they are doing to address different PRC areas and throw those up on the white board. The LWG will conduct a conservation project food web exercise (example below), where we connect partners to project areas. From there we will see who could connect with who and make sure we are maximizing resources without duplicating efforts. We don't know who some potential partners may be, and we need participants in the LWG to identify yourselves and let us know



what you are working on. Expect a thought-provoking worksheet prior to next year's meeting from which we can create a clearing house document of conservation work in Missoula County. Such a document could be provided to local governments and be an asset to obtain future funding for projects.

As LWG facilitators, we would like to hear from you. Do you want to meet again sooner rather than later? Would you like to submit information prior to meeting as a group? What ideas do you have for the LWG? Please feel free to email or call Radley Watkins or Travis Lemke with any thoughts.
